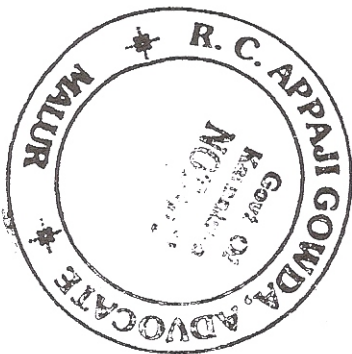



- 4) All other conditions are sufficiently applicable as per Govt Order, Dated 12.12.2003.



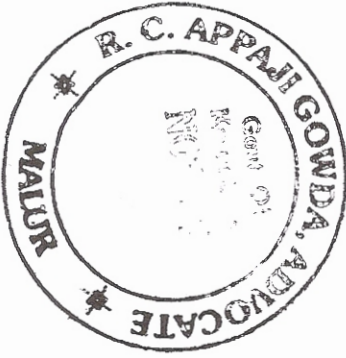

PREFACE:

- 1) The given period of clinical facilities is to the limit of Five years only.
- 2) After receiving of fees according to the number of College students in the current year, the Clinical facilities to be provided for students. Otherwise, the concerned Medical Officer will be held responsible.
- 3) During this period, any loss done by the students, the same will be borne by the Institution itself.
- 4) The clinical facilities should be utilized within three months of the Government Order issued, otherwise such an Orders are to be cancelled.


